Constitution of the Human Rights Cell (HRC)

In exercise of the powers conferred under the *Aryavart International University, Tripura, Act, 2023* (Tripura Act No. 03 of 2023), and in pursuance of the guidelines issued by the University Grants Commission and the National Human Rights Commission for the promotion of human rights education and the establishment of Human Rights Cells in Higher Educational Institutions, the **Human Rights Cell (HRC)** of the University is hereby constituted with the following composition:

Terms of Reference:

1. The term of the Chairperson, the Member-Secretary and the Members of the Cell shall be two (2) years, and that of the student representatives one (1) academic year.
2. The Cell shall promote awareness of human rights among the students, faculty and staff through orientation programmes, sensitisation workshops, lectures, competitions and film screenings, and shall observe Human Rights Day on 10th December every year.
3. The Cell shall undertake outreach and legal-awareness activities in the neighbouring communities, in collaboration with legal aid authorities, non-governmental organisations and civil society institutions.
4. The Cell shall receive representations relating to the violation of human rights within the campus, examine them and place its findings before the Competent Authority, referring matters within the jurisdiction of any statutory committee of the University to that committee.
5. The Cell shall prepare an Annual Plan of activities for approval of the Competent Authority, maintain a record of its activities and submit a periodic report.
